Problems & Responses by Key Themes

The following pages document issues voiced and possible solutions offered during Townhalls

1: Identity & Integration



Youth: Risk of losing confidence in Muslim identity at schools /unis due to Islamophobia & peer pressure



Reverts/Converts: Often isolated, face prejudice even within Muslim communities, lack of mosque integration / support



Turkish & MENA (Middle Eastern and North African)

Communities: Struggling to maintain heritage while integrating with wider UK Muslim landscape (especially language & mosque disconnect)

Refugees: Faith erosion due to neglect by 'settled' communities; some leaving Islam under missionary pressure and more active support from churches

Far East Muslims: Under-represented; identity invisible in mainstream Muslim spaces

2: Welfare, Safeguarding & Support



Reverts/Converts: Vulnerable to abuse: domestic violence, marriage exploitation, abandonment, housing insecurity.

Refugees: Extreme poverty (living on £8.95/week), food insecurity, often no verified halal food provided, trauma/PTSD, children left unsupported (both in education and within Muslim communities).

Mental Health: Taboo, stigma, no NHS faith-sensitive services, lack of trained Imams/teachers/community leaders.

Prisoners: Ex-offenders face stigma (including within Muslim communities and wider society), lack of housing, jobs, and support post-release; prison converts lack safeguarding.

Possible Response:

Faith-sensitive programs (e.g. mentorship, mosques offering English/heritage khutbahs, convert care/refugee support frameworks, supportive madrassas for children).

Possible Response:

Develop Muslim safeguarding frameworks, frontline engagement hubs, connect with psychotherapists with faith sensitive approaches, establish accredited MH & prison chaplaincy programs.

3: Leadership, Safeguarding & Support



Youth & Professionals: No clear pipeline into senior leadership or government representation; Muslims in management often disconnected from their communities.

Turkish, MENA & Far East Muslims: Almost no leadership representation within MCB structures; language and cultural barriers compound exclusion.

Professionals: Struggle with accessing influential Muslims, lack of advocacy at work (bias, freedom of speech restrictions/ censorship particularly around Palestine and other sensitive topics).

Refugees: No united national voice; localised, under-coordinated work, increasing hostility.

Possible Response:
Establish MCB Working Groups or close partnerships for those currently underrepresented (e.g. Turkish, MENA, Far East), support structured youth / professional pipelines, and develop lobbying presence in Parliament / committees.

4: Funding & Resources



Youth (inc FOSIS): Perennial underfunding vs Christian/Jewish youth orgs.

Reverts/Converts: No funding for post-Shahada care, vulnerable to neglect and abuse.

Refugees: Reliant on overstretched orgs; most efforts unfunded. Third sector support is often coming from church groups.

Mental Health: Mosques/charities working on shoestring budgets; NHS ignores faith-sensitive needs.

Professionals: Limited funding restricts reach & programs.

Possible Response::
Need for sustainable funding streams (MCB could highlight funders who offer grants, endowments, affiliate subscriptions etc), and distribute based on mapped need. Support with applications? Joint working?

5: Community Cohesion & Coordination



Professionals: Fragmented across political lines, weakened by lack of collaboration.

Refugees: Scattered efforts, no national coordination, risk of duplication.

Mental Health: Multiple small groups, no joint strategy, stigma, duplication of services.

MENA & Turkish Muslims: Lack integration with South Asian-majority mosques, reinforcing silos.

Possible Response:
Mapping exercises + coalition building (Who's Who in each sector), regular cross-group convenings, and shared best practice frameworks.



6: Islamophobia & Discrimination



Youth: Discrimination in schools, universities, workplaces.

Professionals: Barriers in career progression, silencing Muslim voices.

Refugees: Far-right hostility, systemic neglect, Islamophobia in asylum processes.

Mental Health: NHS bias and lack of faith-sensitive provision.

Prisoners: Structural racism in criminal justice system; converts often doubly stigmatised.


Possible Response:
Advocacy campaigns, legal support, monitoring Islamophobia in institutions (education, NHS, justice system, workplaces), addressing bias within Muslim communities.
